Call for CEV members: Second Job-shadowing at CEV - Visit for Adult Education Staff (Grundtvig Programme), 31st May – 4th June 2010 in Brussels

Following the great success of the first job-shadowing week for members in Brussels last September, CEV plans the second edition to give the opportunity to staff members or volunteers of CEV member organisations to visit the CEV office for a five-day visit from the 31st May – 4th June 2010. This visit is open for up to 15 participants and will give participants the opportunity to gain a deep understanding of CEV's work. The job-shadowing will include workshops, visits to the EU institutions, training on EU funding opportunities, as well as social and networking activities.

Each organisation has to apply to its [National Agency of the Lifelong Learning Programme](#). Deadlines for sending applications vary from country to country. There are no fixed deadlines and each National Agency has its own deadline. In most countries participants should apply in the first half of January 2010 to be able to get funds for joining the Job-shadowing. [Funding rules](#) also vary from country to country, however travel and subsistence costs are always covered, and a contribution to pedagogic, linguistic and cultural preparation are granted in the form of lump sums.

We can assist you with drafting the application that you will submit to your national agencies. Note: It will depend on your national agencies whether they accept to fund your visit. A contribution of 100 EUR per participants towards hosting costs will be expected (it can be included into the contribution to preparation you apply for). As there is big interest of members to participate, places will be allocated on a first come first served basis, but a good regional spread of participants will be also taken into account and CEV is looking forward to welcoming a fresh group of job-shadowers in the CEV office in May/June. **Deadline for expression of interest: 22nd December 2009**
